PREAMBLE:

This Memorandum of Understanding (MOU) is entered into on 28/08/2023, hereinafter referred to as the "28/08/2023," by and between Youth Power Association (YPA) and Digvijay Nath Degree college Gorakhpur, collectively referred to as the "Parties."

BACKGROUND:

Youth Power Association is a non-governmental organization committed to empowering youth through education, skill development, and community engagement. Digvijay Nath Degree college Gorakhpur is an esteemed educational institution dedicated to providing quality higher education to students.

PURPOSE:

The Parties hereby agree to collaborate in a mutual effort to promote educational, cultural, and community development initiatives. This MOU outlines the terms and conditions of their collaboration over a period of three years.

TERMS AND CONDITIONS:

Duration of Agreement:

This MOU shall be in effect for a period of three years, commencing from the Effective Date and terminating on 28/08/2026.

Areas of Collaboration:

The Parties agree to collaborate on the following areas:

Joint workshops, seminars, student counseling and educational events.
Skill development programs for college students organized by YPA.
Community outreach initiatives aimed at promoting social responsibility and civic engagement.

Responsibilities of Youth Power Association:

Youth Power Association shall:

Design and organize skill development workshops.
Coordinate community engagement programs.
Provide necessary resources for the successful execution of joint events.

Responsibilities of Digvijay Nath Degree college Gorakhpur:

The College shall:

Allow the use of its facilities for joint events.
Encourage students' participation in YPA's programs.
One fixed liaison officer will be appointed and one dedicated room will be allotted to YPA by Digvijay Nath Degree college Gorakhpur for better understanding and execution of the all the events.
Promote the collaboration through college communication channels.

Resource Sharing:

The Parties agree to share relevant resources, including educational materials, expertise, and facilities, as required for the collaborative activities.

Financial Arrangements:

Youth Power Association Party shall bear its own costs related to the collaboration and activities unless otherwise agreed upon in writing.

Intellectual Property:

Any intellectual property developed jointly during the collaboration shall be co-owned by the Parties, with usage rights agreed upon separately for each case.

Confidentiality:

The Parties shall treat all non-public information obtained during the collaboration as confidential and shall not disclose it to any third party without prior written consent.

Amendments and Termination:

Any amendments to this MOU must be made in writing and signed by both Parties. Either Party may terminate this MOU with 30 days' written notice.

Governing Law:

This MOU shall be governed by and construed in accordance with the laws of India, without regard to its conflict of law principles.
