

## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is Signed at Gorakhpur (U.P.) on <sup>16<sup>th</sup></sup> day of July, 2022

Between

**DIGVIJAY NATH P. G. COLLEGE GORAKHPUR**

hereinafter called the “First Party” (which expression shall, unless repugnant to the context, includes its successor and assignees of the First Party).

And

**Mahatma Gandhi PG College, Bank Road, Gorakhpur**  
(Affiliated to D. D. U. Gorakhpur University, Gorakhpur)

Having address at Bank Road, Gorakhpur, U.P.- 273001 hereinafter called the “Second Party” (which expression shall, unless repugnant to the context, includes its successor and assignees of the Second Party).

WHEREAS, the First Party has launched Internship, Faculty Development Programs, Short- & Long-Term Training and capacity, Building programs for the students and faculties require as per National Education Policy (NEP).

AND WHEREAS, the Second Party is desired to associate with First Party for conducting Internship, Faculty Development Programs, Short- & Long-Term Training and Capacity Building programs for the students and faculties of the college and agree to send students and faculties to the First Party approved centres and location for the said programs at mutually agreed terms and conditions.

NOW, THE FIRST AND SECOND PARTIES herein and hereby agree to collaborate for the purpose of initiating, developing programmes of Internship, Faculty Development and other training programs offered by First Party.

### 1. Construction of the MoU

- 1.1 The MoU shall be governed by and construed in accordance with the laws of the land.

## 2. Provisions of the MoU

- 2.1 The First Party and the Second Party shall cooperate with each other for fulfilment of their mandates and requirements.
- 2.2 The Second Party shall encourage and facilitate students and faculties of M.G.P.G. College, Bank Road, Gorakhpur to get the Internship, Faculty Development, Skill Development, Training and capacity building from the First Party.
- 2.3 Based on need, First Party may support the M.G.P.G. College, Bank Road, Gorakhpur to design the system in fulfilment of the norms of National Education Policy (NEP) 2020.
- 2.4 The First Party shall conduct examinations and issue certificates to the successful candidates trained under the programs.
- 2.5 The Second Party is responsible for creating awareness among its students' faculties regarding the programs to be offered by the First Party.
- 2.6 The Second Party shall send the details of all students at the time of start of the academic session and semester to the First Party for necessary planning and registration activities. The Second Party shall coordinate with the First Party to select the students for the programs and to send them to the training centres.
- 2.7 First Party will not be liable directly or indirectly for any loss or damage caused to any material or life by any means during conducting the activities during the period or then after.
- 2.8 Second Party shall provide a responsible person to be available all the time to take care of the candidates participating in the activities conducted during the training program.
- 2.9 Second Party shall manage food and lodge at their end if planning to stay at First Party premises.
- 2.10 For various activities, under the program, the cost and modalities may be decided jointly.

3. Amendment

3.1 In case of any amendments are required in any part of the MoU, the Parties on mutual agreement in writing shall incorporate such amendments by way of amendments to this MoU which shall be binding and be followed by the parties.

4. Settlement of disputes

4.1 The Parties shall use their best efforts to settle amicably all disputes arising out of or in connection with this MoU or the interpretation thereof.
