

To provide students practical exposure to programme, technical, advertising, and coordination units through senior editors professionals.


3.5 Research, Documentation and Publication:

Ensure student involvement in practical experience ,skill developement,Portfolio Building, Industry Insight, Desk editing , and field reporting.

Outreach Events: Organize outreach programmes, seminars, or training sessions, in coloboration with College resources as mutually agreed.

4.2 Responsibilities of Digvijay Nath PG College Gorakhpur.

Appoint a Nodal Officer for coordination of activities.

Provide necessary resources of the College as mutually agreed.

Support student participation, promotion, and issuance of joint certificates.

4.3 Joint Responsibilities

Both institutions shall jointly ensure:

Quality of Content: Content shall be educational, factual, creative, socially appropriate, and community-oriented.

Joint Branding: Use of names/logos on content, certificates, promotional, and digital materials shall be based on mutual agreement. *(Related to student/Teacher activities only)*

Programme Coverage: Super Fast Times shall provide media coverage for College campus events.

5. Duration Amendment, and Termination

5.1 Duration: This MoU shall remain effective for three (03) years from the date of signing.

5.2 Renewal: It may be extended or renewed through mutual written consent.

5.3 Amendment: Any amendment shall require joint written approval from both parties.

5.4 Termination: Either party may terminate the MoU by providing 30 days prior written notice.
