- Exchange of academic information and materials of interest.
- Conduct joint research activities and publications. The topics and conditions for utilizing the results, and other forms of co-operation will be determined on a case by case basis by the researchers and administrators of each party.
- Second part will allow registering their students to participate in internship programs.
- Second Part is expected to provide suitable venue to organize programs.
